### 1. PEOPLE'S REPUBLIC OF CHINA (PRC)

#### 中华人民共和国

1.1 **Visa required for ALL** foreign nationals when entering the People's Republic of China except the below listed:

所有海外旅客进入中华人民共和国时必须申请和持有中国签证 (以下地区除外)。

- Hong Kong Special Administration Region (HKSAR) and Macau Special Administration Region Residents can use the 'Mainland Travel Permit for Hong Kong and Macau Residents' when entering the PRC.  
香港特别行政区和澳门特别行政区居民可使用有效港澳居民往来内地通行证 (回乡卡)
- Taiwan Residents should use the 'Mainland Travel Permit for Taiwan Residents' when entering the PRC.  
台湾居民需持有有效台湾居民来往大陆通行证 (台胞证)
- Holders of ordinary passports issued by Japan, Singapore, Brunei, San Marino, Seychelles, Mauritius, Bahamas, Fiji, Grenada, Tonga, Ecuador, Serbia and Barbados can enjoy visa free access to the PRC.

1.2 China visa is exempted for foreign passengers cruising from Hong Kong when they are transiting in Nansha, Guangzhou

- Passengers must prepare a photocopy of passport (bio data page) on a sheet of A4 paper for landing.

- ◆ Guests should request and pay for the VUA via Dream Cruises upon reservation.

- In order to comply with the mandatory requirement of VUA applications (for Member or non-Member)'s VUA booking and deadline of VUA application, VUA (PHVISA07 / PHVISA03) must be created in the SW Reservations Booking System. If VUA code at the SW Reservations Booking System (PHVISA07 / PHVISA03) or applicant's photocopies of passport (submission via Shore Embarkation Team) cannot be timely submitted, then those VUA applications would be denied and rejected. 4.3 Holders of People's Republic of China passport must prepare a photocopy of their passport (bio data page) on A4 paper for clearance purposes.

4.4 PRC nationals holding a valid AJACS – Australia, Japan, America, Canada and Schengen visa, must also hold a valid ticket for their return journey to their port of origin or next port of destination. Passports should have validity of at least 6 months and the duration of stay should not exceed 7 days if they are travelling for leisure.

### 5.2 < Vietnam Landing Visa (Transit) Application / Code: VNVISA08 >

- ◆ Passengers joining Dream Cruises' designated Shore Excursions Programs in Vietnam can apply for a Vietnam Landing Visa (Transit) on arrival in accordance and compliance with the relevant visa regulations and tourism policy. Applicants are required to complete and submit a visa application form and attach one recent colour passport size photo upon check-in for visa application and processing. Please note that any passengers who have made self-arrangements in Vietnam are not eligible to apply for a Vietnam Landing Visa via Dream Cruises and MUST arrange their own Vietnam visa and produce a valid Vietnam visa upon check-in.
